Dining Certificates – (8 Quantity)

Two (2) vouchers entitling the guest for a complimentary welcome meal - Fixed Menu or Buffet for two people. Valid from Monday to Sunday for lunch or dinner. Excluding Sunday brunch. Valid at the All day dining restaurant

Two (2) vouchers entitling the guest for a complimentary buffet breakfast for two people. Valid from Monday to Sunday. Valid at the All-day dining restaurant

Two (2) vouchers entitling the guest for a complimentary round of tea / coffee with cookies for maximum of two guests. Valid at the All-day dining restaurant

BROAD TERMS & CONDITIONS
